Les extraits sont classifiés par rapport à la disposition statutaire (article du Statut, règle du Règlement de procédure et de preuve, norme du Règlement de la Cour) à laquelle ils se rapportent. Un numéro d'identification rapide facilite le renvoi aux extraits des autres décisions sélectionnés dans le présent volume. La présente collection de Codes annotés est avant tout conçue comme un outil à l'usage des praticiens du droit pénal international et des universitaires, qui, grâce au numéro d'identification rapide et à l'index thématique, y trouveront le moyen d'identifier immédiatement les extraits les plus pertinents de la jurisprudence de la Cour sur chaque sujet.
